In the last 15 years, Nathan Stooke went from programming PCs to building Wisper into a successful multi-million-dollar Internet service provider. With headquarters in local Mascoutah, IL, Wisper now services Illinois, Kansas, Missouri, and Oklahoma. In 2018, the FCC announced that Wisper ISP won \$220.3 million of federal funding in the FCC's rural broadband auction (The Connect America Fund Phase II). This money will be distributed to Wisper over a period of ten years. Wisper was one of 103 providers to win financial support from across the country.



Dr Martha Suarez is President of the Dynamic Spectrum Alliance and has over 15 years of experience in the telecommunications industry. In her current role at the DSA, she advocates for laws and regulations that will lead to more efficient and effective spectrum utilization, which is essential to addressing key worldwide social and economic challenges. She spent over three years as General Director of the National Spectrum Agency in Colombia, having originally joined the ANE in 2013. Before that, she was awarded with a Marie Curie Fellowship and worked at the Instytut Technologii Elektronowej ITE in Poland for the Partnership for Cognitive Radio Par4CR European Project. Suarez is an electronics engineer, with a master's degree in high frequency communication systems and is Doctor in electronics from the University Paris-Est.
